nfortunately, Michael is still very ill. This newsletter crept up on us all, so we're doing the best we can as a team. Next month, we should start to feel a rhythm.

As stated at the Board meeting, we are currently **over budget** by **\$61,789**. I hope the information below provides some insight:

Regina also reported to Michael that in January, TV/Cable was over by \$900, due to an increase that was greater than the 4% we

expected. Spectrum has also added channels that we didn't request, which has caused the Local TV Surcharge to increase significantly. If Spectrum corrects these errors, it should provide a more accurate actual number compared to the budget.

We need everyone's help to lower the utilities we can control, which are water, sewer,

and gas. Every time we stop letting water run, we save. Hopefully, our coldest days are behind us.

Greetings, Mission Hills!


Jose is celebrating his birthday this month, so when you see him, please wish him a Happy Birthday!!

- Our annual board election is over. Let's use this opportunity for the community to move forward in a positive and respectful manor.
- Update on our pool...parts arrived and were installed at no cost to us.
- Our fall clean up is done with the leaves being picked up and roofs and gutters cleaned. Found some roofing discrepancies that needed immediate attention. We also donated all refuse to a local organic farmer.
- Sewer lines...we have repaired again this month.
- Dog waste...please pick up after your dog. When you miss it, our mowers run over it or it gets caught up in the weed whackers, not to mention it's unpleasant for your neighbors.
- SAFETY...please be aware of your surroundings on and off our property.





WHAT IS THE COMPLIANCE COMMITTEE?



For several years, Mission Hills residents had been concerned about some By-Law violations with "nothing being done about it."

In June of 2019, Mission Hills established the very first Compliance Committee to help address these issues. Since its inception, there have been over 20 compliance issues that have been resolved without the resident having to appear before the committee...and that's a great thing!

Many, especially our newer residents, might not be aware of the initial steps required to report a By-Laws, Declaration, or Statute 718 violation. It is quite simple, so here we go. *With as much detail as possible, you must send an email to:*

Bob Kelly, our Property Manager, at rkelly@ameritechmail.com.

You must write "MH COMPLIANCE" in the subject line of your message. This is where your participation ends. Remember...your message is strictly confidential. The ONLY people who can identify the sender is that person and our Property Manager.

DO NOT CONTACT THE OFFICE, ANY BOD MEMBER, OR MAINTENANCE!

So what, then, is the role of the Compliance Committee?

Chapter 718 Florida Statutes (718.303(3)(b), dated July, 2018, states, in part that "A fine or suspension levied by the board of administration may not be imposed unless the board first provides at least 14 days' *written notice* to the unit owner and, if applicable, any occupant, licensee, or invitee of the unit owner sought to be fined or suspended, and an opportunity for a hearing before a Committee of at least three members appointed by the Board who are not officers, directors, or employees of the association, or the spouse, parent, child, brother, or sister of an officer or employee. *The role of the Committee is limited to determining whether to confirm or reject the fine or suspension levied by the Board. If the committee does not approve the proposed fine or suspension by majority vote, the fine or suspension may not be imposed."*

The preceding paragraphs are key to understanding the role of a Compliance Committee. The Committee does not search the community for violations, report violations to the Board, nor determine what a fine will be.

What the Committee does, if requested by the resident(s), is meet with him, her, or them, review the situation, and make a recommendation as to whether the fine proposed by the Board is fair and reasonable.
