MAINTENANCE REPORT -

Well Pump – A new well pump was installed in Phase 1 to replace the 17 year old pump.

Plumbing - John said he is accepting a bid from Able Plumbing, so that we do not have to rely on just one company.

Phase 6 – Allen's Plumbing came out twice to do repairs in Phase 6 at no cost to us.

Dryers – The dryers for the north laundry have been ordered.

Miscellaneous – Grass has all been planted, sidewalks have been repaired and asphalt has been repaired.

HVAC – A new HVAC company came in to put the air conditioners back up on Bldg. 4 after John had some challenges with the company that took them down.

Buildings - The roof on Bldg. 4 will be done this week. Sweeping preparation is being done on Bldg. 11. Eight carports will be done by next week.

Maintenance – John will be prioritizing the work that needs to be done. The first priority will be getting the leaves off the roofs and keeping up with the grounds.

Storm Drains – John said that the storm drains are backing up when it rains, they are not big enough to accommodate the heavy rainfall. However, the water recedes as soon as the rain stops.

Art said the speed bumps that have been installed are helping with the speeding.

Finance Report: For the month we are over budget and year to date we are over budget. Year to date is a little down from last month.

Review of Delinquencies – The delinquencies were discussed line by line. Joe made a motion to reject a payoff offer for 54D; 2nd by Art, none opposed; motion passed. Non-payment procedures in place for 5E, 32D, 21F, 4C, 66B, and 85D.
